Library Review/Budget Presentation

Director Beth Paine presented the proposed budget for fiscal year 2024-25. The Proposition on the library vote will be to raise the tax levy for the 2024-25 fiscal year by \$13,814 to increase the annual appropriation from \$1,381,469 to \$1,395,283. This year there will also be a trustee election on the ballot. Norm Argulsky and Jessica Ecock Rotondo will not be running for re-election.

Public Comment

John Deleo praised the Library Board of Trustees, our Library Director Beth Paine and the library staff for continued outstanding service. John Roach used this opportunity to introduce himself as a candidate running for one of the three year term trustee seats which begins July 1, 2024. He gave a brief bio and expressed his support for the library. Cheryl Kowalik also signed up to speak. She has been a library patron for many years. She is an advocate of the library and praised the programs and dedicated staff.

Felipe Oltramari also introduced himself as a candidate for the 2024 trustee election. He summarized his work experience, hobbies, and interests. He said he and his family have been library users and supporters for many years. In addition, his wife Laurie was formerly employed at Richmond Memorial Library as a Library Assistant.

E-rate Update

Director Paine received the go-ahead from e-rate to check the bids for Form 470's that were submitted in February. Spectrum was chosen as the lowest and best constructed quote. The 470 for the technology equipment only received one quote from Info Advantage. This project will update much of the Richmond Library technology and cabling that are well past their replacement time. This project's quote is \$89,831 and would be 85% covered if the application is approved.

Personnel Changes

Sue Potera has resigned as Children's Librarian effective April 5, 2024. Charles Burton was hired as Library Page and Emily LeMaster was hired as a Parttime/Sub Clerk. Katherine Elia was rehired as a Library Assistant at a starting wage of \$21.50/hr. She will be working a four-day workweek and will be starting the week of April 15th.

Eclipse Glasses

All of the eclipse glasses were given out by April 4th. There were 500 pairs set aside to hand out the day of the event.
